# **Strengthen and Expand Social Security!**

## More than 28 percent of Garrett County residents derive all or most of their income from Social Security. This includes adults, children and the disabled.

In the United States:

- Social Security is the major source of income for most of the elderly.
- Disabled workers and their dependents account for 13% of total benefits paid.
- Among elderly Social Security beneficiaries, 48% of married couples and 69% of unmarried persons receive 50% or more of their income from Social Security.
- Among elderly Social Security beneficiaries, 21% of married couples and about 44% of unmarried persons rely on Social Security for 90% or more of their income.

#### **DID YOU KNOW?**

Social Security is an extremely efficient program, with administrative costs of only 0.7% of total expenditures. That's less than a penny for every Social Security dollar collected. Social Security's benefits are extremely *low* by international standards, ranking near the bottom when measured against the old-age benefits provided by other developed countries. The average yearly benefit for individuals in the U.S. is a little over \$15,000.

Social Security is <u>not</u> going broke any time soon. And, with some <u>small</u> changes, the program can be secured for future retirees, survivors and disabled recipients.

#### **DID YOU KNOW?**

Legislation has been introduced in the U.S. House of Representatives to expand and secure Social Security?

**THAT'S RIGHT**... The Social Security 2100 Act, introduced by Rep. John B. Larson (D-CT) would *improve* benefits by 2% and protect against inflation by improving the cost-of-living provision. And it would **increase** benefits for low- income workers. **That's very important to residents of Garrett County where wages severely lag behind Maryland's average.** The Social Security 2100 Act *strengthens* the Social Security Trust Fund by lifting the cap on payroll taxes to wages above \$400,000, affecting only the top 0.4% of wage earners. The legislation would gradually phase in an increase in the contribution rate beginning in 2020, so that by 2043 workers and employers would pay 7.4% instead of 6.2%. For the average worker this means paying only an additional 50 cents per week every year to keep the system solvent.
